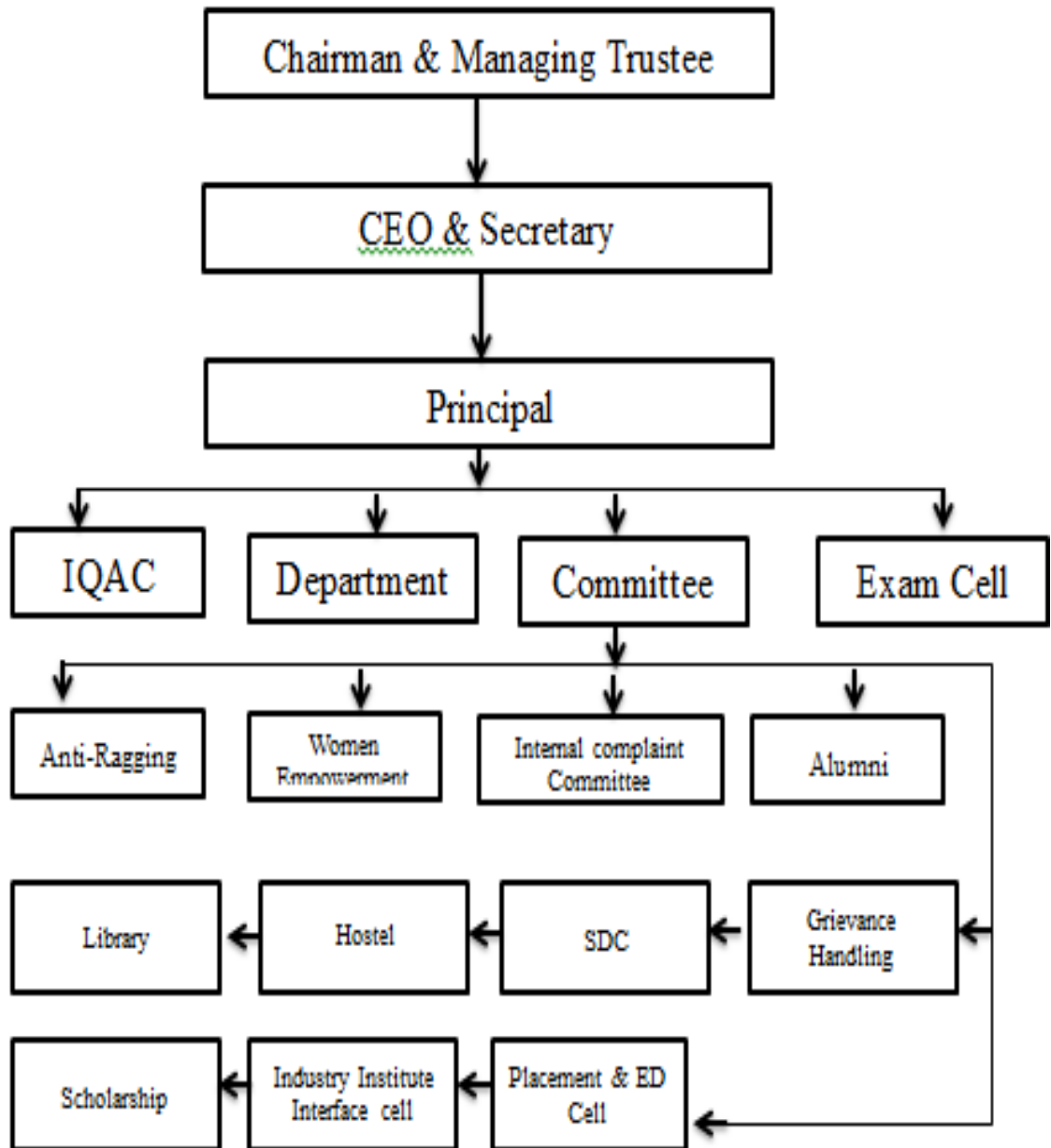

Students of other states or candidates who have not written TANCET Exams should have written CET Examination conducted by Association of Self-Financing Arts, Science & Management Colleges of Tamil Nadu. Admissions are subject to the approval of the University. The decision of the Management regarding the admissions shall be final and binding.

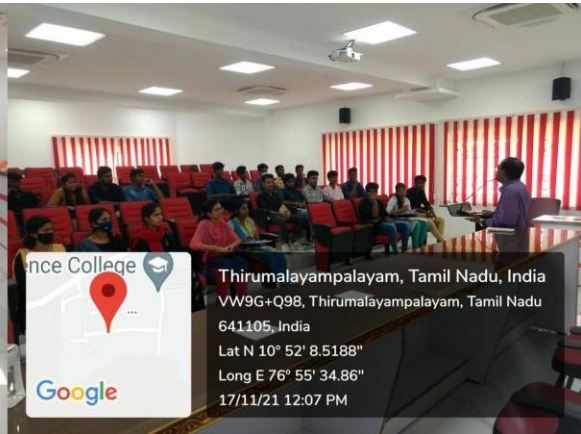
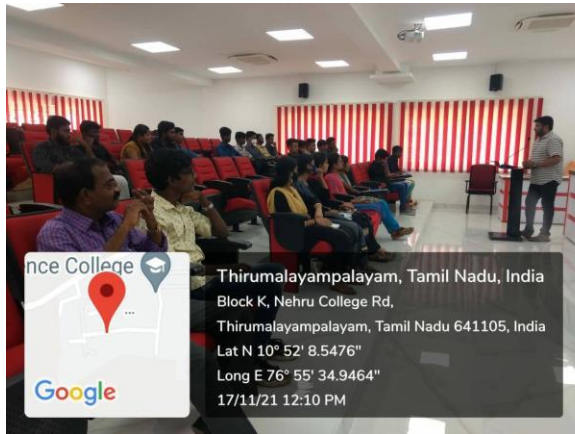
Nehru Group of Institutions Technology Business Incubator (NGI TBI)

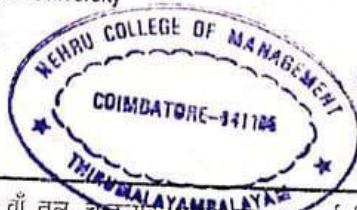


